### Note:

Open water sources are easily contaminated by human or animal waste. Water from springs, lakes, ponds, and streams should be properly treated before drinking. One recommended method of treatment is to bring clear water to a rolling boil for five minutes.

### Trail Description

Don't leave your camera behind. Bald Mountain offers you an incredible view of Little Grass Valley Reservoir and the surrounding area. An eye-catching sight to the east is Blue Nose Mountain, reaching an elevation of 7290 feet. The Bald Mountain Trail climbs 1.4 miles through the forest, arriving at a fork. The left fork continues 0.9 miles to the top of Bald Mountain. The right fork progresses 1.3 miles, meeting the Pacific Crest Trail near Chimney Rock. (The trail is generally open from mid-June to early-September, snow and road conditions permitting.)
